21/PC/10 COLIN GROGAN – GREAT EAST SWIM 2010:

The Great East Swim held at Alton Water last year was generally hailed as a great success by the organisers.

1252 swimmers participated, with approximately 4500 spectators attending.

The event was estimated to have contributed £392k to the local economy in Suffolk, with £85k raised for charities by sponsorship.

The impact on Stutton was considered very low, mainly due to free parking and good traffic management on the day.

This year's event will be held on Saturday 19th June, with a target of 2000 swimmers. (Check with the school that this does not clash with the fete).

The organisers will put up more posters in advance, to increase local publicity.

There may be opportunities for village organisations to benefit from this year's event by holding a tombola or draw.

Considerations:

B/09/01249/FUL – Land south of High Lodge, Church Lane Stutton

Amendments to application received.

The development does not fit in with the street scene, it is too high and an overdevelopment of the site. Recommend refusal.

Babergh Planning held a site visit on 27th January and will be considering the application on 17th February.

Decisions from Babergh District Council:

B/09/01391/FHA Grove House, Lower Street – Construction of tennis court and chain link enclosure – permission granted.

B/09/01022/FHA Crowe Hall – Erection of single storey cartlodge and plantroom – permission granted.

27/PC/10 PLAY AREA:

The request for an Aiming High grant has received a positive reply from Suffolk County Council, who have indicated £6k maximum funding would be available. An S106 application is underway, awaiting quotes for groundworks.

The footpath construction work is scheduled to commence on 15th February. It is anticipated that the Parish Council financial contribution should be minimal.

29/PC/10 VILLAGE PLAN:

A presentation of the plan combined with a neighbourhood watch meeting took place on 26th January. Around 60 members of the public attended. The Parish Council will begin working through the action points, starting at the next meeting.

Work on the new front doors will begin within two weeks. There is a craft and tabletop sale organised for 13th March.
